

REFLECTIONS FROM THE HILL

WE'VE MADE PROGRESS!

Considerable progress had already been achieved when, two years ago, I stepped into the presidency. My predecessors have done an exceptional job and I found myself with large shoes to fill. Attempting to do so has been both a challenge and a rewarding experience.

We have maintained a level of 3,200 members despite the loss of some of our friends and classmates. Dues income has increased slightly over the past two years, yet less than one third of our registered alumni members actually pay their dues.

Many of our recent reunions have been memorable. The events in 2005 and 2006 set a new benchmark, with 88 alumni attending in 2005 and 92 in 2006. Future reunions promise to be even better, with more involvement by our alumni and generous support from VWIL.

As this issue of *The Kablegram* goes to press, our SMA-VWIL Museum Committee is meeting to decide the best way to make use of the additional space that has been granted us by Mary Baldwin College. This is an important step in perpetuating the legacy of SMA.

In April 2004, Bill Kearns handed Dr. Brenda Bryant and Brig. Gen. Michael Bissell a check for \$20,000 and pledged that the SMA Alumni Association would provide \$50,000 a year for discretionary use as long as we could. That pledge was fulfilled by April 2005, and fulfilled again by April 2006, each year through the SMA-VWIL Initiative.

Through the Initiative, your association has opened many opportunities for the Corps of Cadets, including new flags, trips to seminars, leadership retreats, travel to New York for the annual St. Patrick's Day Parade and to Williamsburg for the Inaugural Parade, and an intercom system between dormitories and the VWIL office. This is but a small sampling of benefits the SMA-VWIL Initiative has provided.

VWIL cadets have enjoyed the benefits of a series of annual scholarships funded by Hunter W., Henry, Jr., SMA '46 and the SMA Alumni Association. Other tuition assistance grants have been provided when the circumstances warranted and our help was requested.

Recently, we completed a program that resulted in placing furniture and computers in seven areas of VWIL that were set aside for cadet offices and conference rooms, accomplished through private donations.

Without the enthusiastic support of the SMA Alumni Association Board of Directors, always there when I needed help and guidance, none of our accomplishments would have seen the light of day. You — our alumni — should be very proud of those you elected to guide our organization.

There is no time to rest on our laurels. There is more to be done. The museum expansion is high on the list of projects, as is the Scholarship Fund, the SMA-VWIL Initiative, and locating more and more alumni and bringing them on board.

I hope you will respond to the annual dues and contribution mailing that you should by now have received. Your dues and donations keep the SMA Alumni Association and the SMA Foundation afloat and give us the means with which we can continue to grow and see progress.

As you know, those of us who serve on the Board of Directors are only the caretakers of your association. Thank you! for your support. Thank you for your periodic messages of encouragement, your feedback and suggestions, and your involvement!

We could not do it without your help!



SMA-VWIL Museum to undergo expansion

Shortly after the 2006 reunion, Mary Baldwin College (MBC) approved the proposed expansion of the SMA-VWIL Museum, located in what was once the SMA Supply Room.

Under the leadership of Brig. Gen. Michael Bissell, VWIL Commandant, in conjunction with the SMA Alumni Association Board of Directors, the proposal went through a review process within MBC and resulted in an expansion plan that will add approximately 1,200 square feet to the facility that now has 1,385 square feet. A small area will remain available for storage by Mary Baldwin College.



All recommendations for the

three projects will be reviewed by the Board of Directors before funding and action is approved.

Harry W. Bruckno, SMA '62, vice president of the SMA Alumni Association and a member of the SMA-VWIL Committee, said that "feedback from our alumni is important to this effort, including suggestions of what our members would like to see in the museum."

Dues are due...

...for the next fiscal year, September 1, 2006 through August 31, 2007. The annual dues and contributions request was mailed prior to publication of this issue of *The Kablegram* and should by now have been received by all SMA alumni.

Dues and contributions are what keep the SMA Alumni Association in operation, paying bills associated with maintaining an alumni office, publishing *The Kablegram*, and providing the services that SMA alumni require to remain active.

In recent years, less that 25 percent of our registered 3,100 association members have paid annual dues of \$50.00, while all members have benefitted from the services provided. Our organization needs the financial support provided through the dues in order to continue to maintain services and perpetuate the legacy of Staunton Military Academy.

Also in need of support is the *Scholarship Fund*, which each year provides a \$1,000 SMA Alumni Association Leadership Award to a cadet designated by the VWIL administration. The goal for 2006-2007 is to increase this fund to \$50,000 so that future awards can be increased to \$2,500 annually.

The *SMA-VWIL Initiative* is still an active fund which provides money to VWIL for discretionary spending, including the expenses associated with the annual trip to the St. Patrick's Day Parade in New York, various leadership seminars for selected cadets, and other Corps of Cadets activities that might not otherwise be funded.

The SMA Foundation also maintains a *VWIL Band Fund* and a *VWIL Howie Rifles Fund* to which contributions have been targeted by SMA alumni interested in those two area. Those funds are provided to VWIL as needs are identified and subsequently approved by the Board of Directors.

Targeted effort by SMA alumni began in May 2005

Computer and furniture acquisition program concluded

Slightly more than a year ago at the end of the 2004-2005 academic year at the Virginia Women's Institute for Women (VWIL), the SMA Alumni Association (SMAAA) became aware of specific furniture and computer needs associated with the new program that placed upperclass cadets in both Kable Hall and Tullidge Hall. The goal was to house the Corps of Cadets sophomore, junior and senior class cadets in two dormitories and thereby enhance the organization of the corps.

Several members of the SMA Alumni Association made a commitment seek appropriate furniture and computer equipment, upgrading the technology to Mary Baldwin College specifications, and then donating the items to VWIL.

This effort became more of a challenge than originally anticipated. The initial goal was to have everything in place by the beginning of the 2005-2006 academic year — a goal that proved impossible to meet.

The effort continued throughout the past year and culminated in June and July of this year with the delivery to VWIL of a variety of furniture and computer technology. When the Corps of Cadets returns August 24, there will be fully furnished cadet offices and separate cadet conference rooms in Kable Hall for both the senior class and junior class. The same will be available in Tullidge Hall for the sophomore class.

Another focus of the program was to assist VWIL in the creation of a professional Operations Center at the headquarters on North Market Street. This was accomplished in late July, and a separate ROTC office was established on the second floor where the Operations Center once was. A computer donated by **Ryan Zook**, an agent with Long and Foster Real Estate in Reston, Virginia was placed in that office for use by cadets and ROTC advisors.

Of the people and organizations involved in this effort, many have no association with Mary Baldwin College or VWIL, but have responded to contacts by the SMA Alumni Association team that managed the program.

In the VWIL Operations Center, an HP Media Center computer, powerful enough to edit videotape and create professional presentations and DVDs, was provided by **Mr. and Mrs. Kenneth Rutland** of Oak Hill, Virginia. The Rutlands had previously provided several printers and computer peripherals.

G. Richard Staunch, SMA '61, contributed a 21-inch computer monitor to the Operations Center, and the *SMA-VWIL Initiative* was used to purchase 10 conference room chairs compatible with the 48-inch by 96-inch conference table that was purchased with funding from an anonymous SMA alumnus. Mr. Zook, whose computer went to the ROTC office, also donated a four-speaker sound system to be used in the Operations Center as well as other technology peripherals for use in areas were they were needed.

Recognizing that not everything needed could be located through donations, **William J. Kearns**, **SMA** '**74**, chairman of the *SMA-VWIL Initiative* Committee, arranged for a \$5,000 cash donation to VWIL to be used specifically to purchase furniture not found among the donated items.

During the initial stages of the program, **Michael Guthrie**, then the managing broker of the Long and Foster Real Estate office in Reston, Virginia, provided a laptop computer (used in 2005-2006 by the cadet S-2 staff). He then began a campaign within the Reston office to bring other agents into the program with donations of furniture and technology.

Mr. Guthrie departed Long and Foster Real Estate and became Vice President of Roy Wheeler Real Estate in Charlottesville, Virginia. More recently he arranged for the donation of four computers by Virginia National Bank. One of these computers was used for spare parts to bring other CPU's up to Mary Baldwin College standards. A second computer was upgraded and placed within VWIL. The two remaining units are being upgraded and help in reserve, with one scheduled to eventually be installed in the VWIL Supply Room to replace the much older unit now there.

Mrs. Boofie O'Gorman, an agent with Long and Foster Real Estate in Reston, donated an HP Pavilion computer and related peripherals, along with various cabinets, tables and office chairs. The computer has been assigned to use within VWIL and the furniture is in use in the cadet offices. Mrs. O'Gorman also introduced a member of the SMAAA team to several of her clients who have committed to contributing additional pieces of furniture for use at VWIL.

Mrs. Shiela Gant of Herndon, Virginia donated several items of furniture that have been placed in cadet offices.

In July of this year, Mary Baldwin College's Coordinator of User Services, **Rich vanBreemen**, notified VWIL that six computers — all configured for use on the college network — would be provided, with two units to be installed in each of the three cadet offices and maintained by Mary Baldwin College.

Several other people made significant contributions to this yearlong effort. **Michael Lassiter**, a computer technician in Herndon, Virginia, donated many hours of his time to repair and upgrade much of the technology, and tutored me to do the same. **Thomas Baxter**, also of Herndon, used his trailer to transport furniture to VWIL, and **Harry W. Bruckno, SMA '62**, traveled to Northern Virginia, picked up a truck load of furniture and delivered it to VWIL.

All equipment and furniture contributions were documented and acknowledged, enabling the donors will be eligible for the appropriate tax deductions.

Chief Petty Officer Rick D. Schemehorn, Assistant Commandant at VWIL, served as VWIEs on-site coordinator of the program, insuring that offices and conference rooms were adequately furnished, utilizing contributed funds to purchase items that could not be acquired through donation, and serving as liaison with the SMA Alumni Association team.

"Thank You!" seems inadequate in expressing our appreciation to everyone who participated. The generosity of those who responded to the SMAAA requests was outstanding. There is now great satisfaction in having achieved a goal that at times appeared unattainable.

WILLIAM SHERMAN DIFFEE, SR., SMA '52


