Donating to a Charity Using a Qualified Charitable Distribution (QCD)

If you are age 73¹ or older, IRS rules require you to take required minimum distributions (RMDs) each year from your tax-deferred retirement accounts.

A qualified charitable distribution (QCD) is a direct transfer of funds from your IRA, payable directly to a qualified charity, as described in the QCD provision in the Internal Revenue Code. Amounts distributed as a QCD can be counted toward satisfying your RMD for the year, up to \$100,000. The QCD is excluded from your taxable income. This is not the case with a regular withdrawal from an IRA, even if you use the money to make a charitable contribution later on. If you take a withdrawal, the funds would be counted as taxable income even if you later offset that income with the charitable contribution deduction.

Why is this distinction important? If you take the RMD as income, instead of as a QCD, your RMD will count as taxable income. This additional taxable income may push you into a higher tax bracket and may also reduce your eligibility for certain tax credits and deductions. To eliminate or reduce the impact of RMD income, charitably inclined investors may want to consider making a (QCD). For example, your taxable income helps determine

the amount of your Social Security benefits that are subject to taxes. Keeping your taxable income level lower may also help reduce your potential exposure to the Medicare surtax.

QCDs may provide many SMA "boomers" a mutually beneficial solution to lower taxable income while simultaneously helping your charity of choice.

¹The change in the RMDs age requirement from 72 to 73 applies only to individuals who turn 72 on or after January 1, 2023. After you reach age 73, the IRS generally requires you to withdraw an RMD annually from your tax-advantaged retirement accounts (excluding Roth IRAs, and Roth accounts in employer retirement plan accounts starting in 2024). Please speak with your tax advisor regarding the impact of this change on future RMDs.

STAUNTON MILITARY ACADEMY ALUMNI FOUNDATION LEGACY SCHOLARSHIP PROGRAM

WHAT IS IT?

A scholarship program intended to perpetuate the legacy of Staunton Military Academy (SMA). SMA was a special place for many young men from 1884 until it closed in 1976. Through this scholarship program, the alumni of SMA hope to preserve the memory of our school and what it has meant to all of us by helping young people who share the values and ideals for which SMA stood.

WHAT ARE THE TERMS OF THE SCHOLARSHIP?

Two Legacy Scholarships with a minimum value of \$2,500 will be awarded annually. No extensions of the scholarship are authorized. Scholarship selections will be based on merit, and applicants will be evaluated on a whole-person basis, including evidence of commitment to the values "Truth-Duty-Honor," which is especially important to us. Application deadline is 1 July each year.

WHO MAY APPLY?

Only descendants of SMA alumni who are graduating high-school seniors who have acceptance at a two- or four-year colleges may apply. There is no requirement for students to attend a military college or to enroll in ROTC. In fact, the only exclusions from participation are descendants planning to attend the U.S. Military Academy at West Point, the Naval Academy, the Air Force Academy, or the Coast Guard Academy.

HOW CAN A STUDENT APPLY?

SMA descendants who desire to apply for one of the Legacy Scholarships must submit his or her application in an email containing all elements shown below. That application, with all required attachments, must be sent to the SMA Alumni Foundation Office at scholarship@sma-alumni.org not later than 1 July of the year of graduation.

The following information must be included in the body of the emailed applications unless otherwise indicated below with an asterisk:

- First, middle, and last name of the applicant
- Full Mailing Address
- Email Address
- Phone number (including area code)
- The name of the SMA Cadet from whom the applicant is descended, the year he graduated from SMA, and the applicant's relationship to that SMA Cadet.

Cover Letter: Formally request an SMA Legacy Scholarship and provide information regarding your plans for the future. Describe what the words, "Truth, Duty, and Honor," mean to you and indicate how those words have been applicable in your personal relationships. Include your academic/extracurricular activities both inside and outside school.

One of the following essays must be attached to the email application:

- Essay One: Describe a circumstance, obstacle or conflict in your life, and the skills and resources you used to resolve it. Did it change you? If so, how? Indicate how truth, duty and honor were involved.
- Essay Two: Considering your lifetime goals, discuss how your current academic and extracurricular activities might help you achieve those goals. Include how truth, duty and honor were involved.
- *The following external documents must be attached to your application or otherwise provided to the SMA Foundation as indicated:
- A letter of recommendation from a member of the faculty (a teacher, for example) of the applicant's high school. As required by the applicant's school, this document may either be attached to the applicant's email or emailed not later than 1 July by the school directly to the Foundation Office at scholarship@sma-alumni.org.
- A letter of recommendation from one adult outside of the school.
- A copy of the letter of acceptance to a two- or four-year college.
- A copy of the applicant's transcripts through grade 12. (Transcripts may be either attached to the applicant's email or, if necessary, emailed by a school official by 1 July.
- Scores: SAT (total) _____ and/or ACT____ (Any score listed must be documented in the applicant's transcript or provided by a separate attached document originated by the testing activity, or a screen shot from the student's account on the SAT/ACT website.)

Additional Information: When an applicant is selected for a Scholarship, a personal photograph and short biography must be received by the Committee before monies can be dispersed. We will request these items at the time the applicant is notified of his or her award.



He owned and operated the former Hano Business Forms in Springfield for many years with his family. He was also a past master of the Mt. Holyoke Lodge of Masons. He leaves his beloved sister, Jodi Hano and her husband John Sequeira of Tiverton, RI. All services were private and the Wilbraham Funeral Home is in charge of arrangements.

John Martindale Heaner Obituary

John Martindale Heaner (Marty), age 87, died peacefully in his sleep on May 28, 2023, with his son Marty, Jr., by his side.



Marty was born on September 14, 1935, in Brownsville, Texas to William E. Heaner and Annie Starck Heaner. A Brownsville

native, Marty can trace his roots back to the founding families of the city. His great great grandmother mar-

ried Mifflin Kenedy who came to the area in the 1840's. Marty was a descendant of Petra V Kenedy and her daughter, Maria Vicenta Vidal Starck.

Marty attended Staunton Military Academy in Virginia, where he graduated in 1953. Upon returning to Texas, he enrolled at the University of Texas at Austin, pledged Kappa Sigma Fraternity, was a member of the National Champion Pistol Team and completed ROTC Military Police training. He graduated with a Bachelor's Degree in Business Administration in 1957.

He obtained the rank of Captain in the U.S. Army, then remained in the Army Reserves until 1967.

Marty joined his father, W.E. "Red" Heaner in the family business in 1958. In the next 12 years, Marty learned the construction business from the ground up. The company was Valley wide so he was up before daylight to get an early start checking the jobs from Rio Grande City to South Padre Island.

He was President of the Construction Division of Valley Inn and Country Club where he was instrumental in the construction of many homes at VICC and the planned community of Rancho Viejo Country Club. Marty started his own residential construction company in the 1970's where

he built the Casa Linda, Sugartree I and II, Lakeway and Briarwyck subdivisions.

Marty served on the board of the Brownsville Economic Development Corp. and Texas Commerce Bank. He was an active member of the Church of the Advent, Episcopal. He served on the Vestry and was appointed Jr. Warden. Marty was part of the Cursillo movement and part of five teams acting as Rector on the last one. He was Advent-Vision 2000

Chairman during the Diocesan Campaign. Marty was baptized and confirmed into the Roman Catholic faith at Sacred Heart Church in Brownsville. He was received into the Episcopal Tradition by the Rev. James Folts on November 29, 1987.

An avid hunter, outdoorsman, horseman and dog owner. He was also a licensed pilot.

He is predeceased by his wife Glenda Kay Turner Heaner and his sister Anne Heaner Glenn. He is survived by his son John M. Heaner, Jr., his wife Anne, and grandson John M. Heaner III, and

his son Michael Lewis Heaner, his husband David Michaud, and his niece Maria Glenn Uecker.


